

Homeopathy Exceptional Funding Request

Homeopathy is not routinely commissioned.

Bristol, North Somerset and South Gloucestershire Integrated Care Board (BNSSG ICB) is responsible for making the best use of the NHS funds allocated to us to meet the health needs of our local population. The demand for services is greater than the resources available and therefore we have to prioritise the use of funds carefully. Our approach is to prioritise commissioning treatments, operations or drugs that are most effective in meeting the health needs of the population. All operations carry significant risks and where symptoms are mild or moderate it is likely that the risks outweigh the benefits. Not all conditions progress and when symptoms can be managed conservatively, that is the safest option.

Homeopathy – Plain Language Summary

Homeopathy is a complementary or alternative medicine. This means that homeopathy is different from treatments that are part of conventional Western medicine in important ways.

A central principle of Homeopathy is 'like cures like'. This means that a substance that causes certain symptoms can also help to remove those symptoms.

A second central principle is based around a process of dilution and shaking called succussion.

Practitioners believe that the more a substance is diluted in this way, the greater its power to treat symptoms.

Many homeopathic remedies consist of substances that have been diluted many times in water until there's none, or almost none, of the original substance left.

Homeopathy is used to 'treat' an extremely wide range of conditions, including physical conditions such as asthma and psychological conditions such as depression.
