1.1 The aim of this report is to provide the Primary Care Commissioning Committee with an overview of primary medical contracting and commissioning activity in the Bristol, North Somerset and South Gloucestershire area.

2.1 PMS Contract Update

Updated PMS contracts have been issued by NHS England, to reflect the outcome of the recent PMS Review. Some practices have requested clarification of the documentation prior to signing.

The medical team are currently reviewing all single-handed contracts. The Single Handed GP Contractor Assurance Framework has been circulated to CCGs and LMCs for comment. The final version will be sent to practices in April for completion.

2.3 National contract negotiations for 2018/19

The contract for 2018/19 will see an overall increase of 3.4 per cent. Key changes for 18/19 include:

- investment to cover GP indemnity costs for 2017/18
- ➤ an uplift to allow an increase to the Item of Service (IoS) fee for certain vaccination and immunisations (V&I) from £9.80 to £10.06, in line with consumer price index inflation
- an uplift to allow a change in the value of a Quality and Outcomes Framework (QOF) point as a result of a Contractor Population Index (CPI) adjustment
- ➤ a non-recurrent investment to recognise additional workload associated with the implementation of e-Referral contractual requirements.

There are further key changes relating to use of the Electronic Prescription Service (EPS) and NHS e-Referral Service (e-RS), as well as contractual changes around advertising, violent patients, patient access to online services and out of hours services
