Report Title: - GP Contract Reform Update March 2019

1. Introduction

On Thursday 31st January NHS England Board published 'Investment and evolution: A five-year framework for GP contract reform to implement The NHS Long Term Plan' (31 January 2019: - NHs England and BMA).

This paper seeks to update the committee on the immediate communication and engagement plan with regards to the new contract.

2. Background

The document published on 31 January 2019, sets out agreements between NHS England, the BMA General Practitioners Committee (GPC) in England, supported by Government to translate commitments in the NHS Long Term Plan into a five-year framework for the GP services contract. It confirms the direction for primary care over the next ten years whilst seeking to meet the reasonable aspirations of the profession.

Specifically, the agreement:

- Seeks to address workload issues resulting from workforce shortfall
- · Brings a permanent solution to indemnity costs and coverage
- Improves the Quality and Outcomes Framework (QOF)
- Introduces automatic entitlement to a new Primary Care Network (PCN) Contract
- Helps join-up urgent care services
- Enables practices and patients to benefit from digital technologies
- Delivers new services to achieve NHS Long Term Plan commitments
- Gives five-year funding clarity and certainty for practices.

An overview of the contract framework was shared with the Committee at the February meeting and it was agreed that a communication plan, particularly with practices, in the first instance is needed to address the questions which arise from this significant contract reform. This paper lists the key engagement opportunities prior to the deadline for practices to register as part of Primary Care Networks by 15th May in order to become established from 1 July 2019.

In addition to this, updates on Primary Care Network developments will be shared with the Integrated Care Steering Group to keep key system partners appraised of developments.

These engagement events focus on how PCNs can build on the good work in our system and further contribute to delivering the goals of our system to deliver more integrated out of hospital care. They also focus on the contractual requirements of practices and the role of the CCG and LMC in supporting this. We are actively working with the LMC, locality provider leads and One Care Ltd to develop both our immediate and longer term engagement plan beyond the PCN registration deadline. We will work with PCN clinical directors to develop this further as these become established over the next few months.

A more detailed update and implementation plan will be shared with the Committee in April when the detailed guidance has been published in March.
