Informal discussions are underway with regional primary care finance team and Regional DoFs regarding overall ICS finance framework. In year funding secured due to temporary Covid finance regime therefore funding risk is low. Further guidance awaited on Primary Care DES allocations eg. Investment & Impact Fund. Also, no national finance decisions yet on when NHS will transition back to BAU funding regime, or whether the allocations will change upon transition to ICS. It is not an appropriate time to escalate formally to NHS England.</p> <p>It was confirmed that the action related to a national issue.
