Discussions are currently on hold due to covid-19. Funding has been provided to cover the underlying deficit. Deadline extended to January 2020. Deadline extension to June 2021 agreed at January Committee Request a further extension to October 2021. Informal discussions are underway with regional primary care finance team and Regional DoFs regarding overall ICS finance framework. In year funding secured due to temporary Covid finance regime therefore funding risk is low. Further guidance awaited on Primary Care DES allocations eg. Investment & Impact Fund. Also, no national finance decisions yet on when NHS will transition back to BAU funding regime, or whether the allocations will change upon transition to ICS. It is not an appropriate time to escalate formally to NHS England.	open

UHBW uses it for all documents and NBT is moving onto it and will move its discharge summaries onto this platform. There are no plans for a single electronic record as the primary system across all organisations, the requirements of each sector are quite different and there is not a single system that will do everything.
