This action plan should be reviewed after 6 months and at appropriate intervals thereafter.

In addition to the Urology specific recommendations outlined above, this Equality Impact Assessment identified a number of general recommendations. These activities are covered by Trust-wide inductions and training programmes already, but it is recommended that the Project Manager highlights these to the Training and Development team to demonstrate their importance in service delivery. These recommendations are to include the following in the statutory and mandatory training for staff:

- Mental health training.
- Training around consent and confidentiality.
- Training on how to treat people with respect and dignity.
- Training on the use of plain English.
- Awareness of different options for communicating with patients with sensory impairments and how to access these options.
- Awareness of how to access/ translate information into a suitable format for patients with learning disabilities.
- Awareness of potential sensitivities for patients who have undergone gender reassignment.
- Awareness of how to access/ translate information into other languages.
- Awareness of different sexual orientations.
