

Paper 1: 2021-22 Research Capability Funding Spending against the Spending Plan

Date: 13/04/2022 Author: Paul Roy

Purpose

This paper shows the 2021/22 RCF Spending Plan and the actual spending. The aim is to identify and explain any variance between the Plan and the actual spend.

Section 1 shows the spend by Category, and presents the planned and the actual spend, identifies the variance and provides a reason for the variance.

Section 2 shows the itemised spend listed by category for transparency of spend.

The Advisory Group is asked to:

- 1. consider the variance presented and the reasons provided in Section 1
- 2. scrutinise the within-Category spend in Section 2, with the intention of highlighting any inappropriate use of funding, and providing advice where use could be improved,
- 3. advise on whether we should publish Section 1 of this document on our website.

The Spending Plan and actual Spend by Category

We were able to move funds from substantial underspends in Categories 2&3, 4, 6, Before actioning, the plan to increase this budget, and was checked with Nick Kennedy and Peter Brindle.


