

## BNSSG Integrated Care Board (ICB) Joint capital resource use plan – 2022/23 Date: 19<sup>th</sup> May 2023

The Health and Social Care Act 2022, sets out a new requirement for integrated care boards (ICBs) and their partner NHS trusts and NHS foundation trusts to publish joint resource capital plans.

The Act established ICBs from 1<sup>st</sup> July 2022, and for the financial year 2022/23 the Act requires that the capital resource plan must cover the first 9 months of the ICBs operations. For full disclosure, the ICB has chosen to publish the initial outline plan for the entirety of the 2022/23 financial year, covering 12 months, but not updated for additional sources of funding allocated during the financial year.
