# Abdominal Loose Skin & Soft Tissue Removal – Plain Language Summary

A tummy tuck, or abdominoplasty, is cosmetic surgery to improve the shape of the tummy area (abdomen). It can involve removing excess loose skin, fat and stretch marks and tightening the abdominal muscles. The aim is to remove excess skin on the tummy that cannot be removed through exercise – for example, excess skin caused by pregnancy or losing a lot of weight.
