<p>I am writing to you under the Freedom of Information Act 2000 to request a detailed breakdown of the hospital beds within your jurisdiction. Specifically, I would like the following information in an Excel format (1 row per service):</p> <p>A list of all hospitals registered with the Care Quality Commission (CQC) within your ICB area. My preference is for this to be provided using the same "Location Name" and "Location ID" as specified by the CQC, so that I can accurately identify each hospital. I already have access to the CQC data, but I would appreciate it if you could present it in this consistent format.</p> <p>For each hospital, please provide:</p> <ol style="list-style-type: none"> 1. The total number of beds. 2. A breakdown of total number of beds by bed types, as coded by the national definitions listed by the NHS here: 	<p>Information relating to the number of hospital beds is already in the public domain via NHSE: https://www.england.nhs.uk/statistics/statistical-work-areas/bed-availability-and-occupancy/</p> <p>This site contains guidance on how the figures are calculated and information about what metrics should be combined to provide a total figure. Any queries relating to this data should be directed to NHSE using the contact information provided on the webpage.</p> <p>For the BNSSG area, our main acute hospital Organisation Codes are 'RA7' and 'RVJ' – these codes can be used to filter to Acute providers in our area on the spreadsheets available at the above link. The relevant column will typically be called 'organisation code' or similar.</p> <p>The ICB does not hold additional information to provide a breakdown of Bed Types using the list provided.
