Please confirm the number of applications for NHS Continuing Healthcare that the NHS Bristol, North Somerset and South Gloucestershire ICB received in the years 2021, 2022, 2023 and 2024 in respect of:               <ol style="list-style-type: none"> <li>i. People with PSP</li> <li>ii. People with CBD</li> </ol> </li> </ol>	<p>The ICB does not hold the data in the format requested as CHC assessments are not held by the PSP, CBD or CBS characteristics requested in the FOI.</p> <p>The ICB receives over 3300 referrals each year. To source this data would require a case-by-case review of each assessment.</p> <p>The ICB has calculated that this would take over 100 hours to provide the response which is more than the 18 hours appropriate under the FOI Act, therefore the ICB has exempted the information under Section 12 (Cost compliance exceeds appropriate limit).</p>

To assist you in fulfilling this request, in ICD-10 (2019) PSP is coded as G23.1, and in ICD-11 (2024) it is coded as 8A00.10.

CBD does not have a distinct ICD code but may be recorded as corticobasal degeneration or corticobasal syndrome.
